1. Eligibility Criteria

- 1.1. The Bidder/Supplier shall have a turnover of a minimum Rs. 10 Crore in each of the last three years or average turnover of Rs. 10 Crores of the last three years.
- 1.2. Bidder should have a minimum of one installation of similar nature in the last five years
- 1.3. Bidder/Sub-vendor must have manufacturer's authorization OR they shall be a manufacturer.

2. Purchase of Bidding Documents

- 2.1. The bid document may be purchased by interested bidders on submission of a written application (through E-mail yogendra.sodha@amul.coop, bhargav.kanabar@amul.coop) registration on our purchase portal (<http://afdpurchase.amul.in/>) and payment of non-refundable price of the bid document (Rs. 5,000/-) through RTGS/NEFT/Fund Transfer to AmulFed Dairy, A Unit of Gujarat Co-operative Milk Marketing Federation (Bank details are as mentioned below) on all working days (Monday to Saturday, except public holiday).

3. Submission of Bid

- 3.1. The bidders, who purchase the bidding document, are eligible for submission of bids in their name only.

4. Bid Security

4.1 All bids must be accompanied by bid security (Earnest Money Deposit – EMD) in the form specified in the bidding document. The bids not accompanied by EMD shall be summarily REJECTED. The bid security shall be denominated in Indian Rupees of value as specified and shall be in the form of Bank Guarantee from Nationalized or Scheduled Banks or Through RTGS/Fund Transfer (Bank detail is as below for your reference)

4.2 The Bid security may be forfeited if

- ❖ A bidder or supplier withdraws its bid during the period of bid validity specified by the bidder/ supplier on the bid form or
- ❖ In case of successful bidder/ supplier, if the bidder/ supplier fails to sign the contract.
