You may please note that our Terms & Conditions would be as under:-

1. **Prices:** Should be **inclusive of GST**. Octroi/Entry Tax, if any would be extra. **Buy-back price/value to be indicated separately.**
2. **Delivery & Installation:** **Free Delivery and installation at our various Offices across the country within one month form date of PO.** The Delivery should be strictly as per our delivery schedule/period. **For every one week delay in delivery, the penalty of 1% of the total order value will be levied**, which will be deducted from the payment to be released.
3. **Warranty:** **4 years Onsite Comprehensive Warranty**, which includes all the spares.
4. **Payment Terms:** "90% of the order value would be paid **against delivery** and balance 10% **on** satisfactory installation of the PCs across our offices and against **submission of a Performance Bank Guarantee** for 10% of the total value of this order, as per our prescribed format."
5. **Billing :-** Billing should be on our Head Office, Anand for all locations.
6. **Uptime guarantee:** Vendor will guarantee that the downtime of the equipment supplied would not exceed 30 working hours in a quarter. The downtime shall be considered from the time the vendor has been intimated about the failure of the system hardware by GCMMF Ltd. If any defect is noticed during the warranty period which affects the day-to-day operation of the printer, then an immediate temporary replacement has to be provided till the defect is rectified. However, in any case, the downtime for rectification of a problem reported, should not exceed two working days in a quarter.

The quarters shall be as follows:

April-June; July-September; October-December; January-March

For every 6 hours increase in the downtime, over and above the 30 working hours in a quarter, there will be a penalty of 0.5% of the pro-rata hardware cost with a maximum of 10%.

7. Annual Maintenance Contract after Warranty: On expiry of warranty GCMMF may choose to enter into an Annual Maintenance Contract with the vendor. This will be decided and communicated at the time of expiry of the Warranty period. If GCMMF chooses to enter into Annual Maintenance Contract then, the charges for the same will not exceed 08% of the hardware price after taking into consideration the charges for three years warranty.
8. All India Support: The Vendor will be required to provide onsite support during the warranty period at all our offices across the country. You need to provide the details(Name, Address & Contact Nos.) of service support providers against each of our office locations alongwith Escalation Matrix.
9. Buy-back Machines: The vendor will have to lift all the buy-back machines in “**As is Where Conditions**”, from our respective locations within one month from installation of new machines, on his own cost. In case the vendor fails to lift these machines within stipulated time, GCMMF will scrap the same and any expense incurred thereon will be recovered from the payment/BG.

We request you to **send us your most competitive offer/quotation in the sealed envelope only marked as “Offer for Computer Hardware”, by courier so as to reach us on or before **13 October 2017****. The prices should be inclusive of taxes, duty and free delivery & installations at our various sites.
