Product to be passed: nuts like Almond, cashew, pista, chocolate chips, Cookies, Butterscotch Chikki, Brownie, Anjir (max3%), Raisin (moisture max10%) etc

Product passing capacity -500Kg/Hr. through metal detector in form of powder as well as whole.
