- The price should be quoted on F.O.R basis inclusive of packing and forwarding, freight etc (You may consider vehicle of 5 MT or 7 MT based on our delivery schedule and keep stocks of material available at your warehouse with proper buffer based on seasonal consumption)
- Price should be inclusive of all the taxes and other applicable charges etc., or it should be mentioned separately in your offer clearly.
- Realistic earliest delivery period should be indicated.
- It is not binding on us to accept lowest offer and it will be strictly on merit basis.
- Right to reject any or all the offers without assigning any reason is reserved by AmulFed Dairy.
- Offer which are incomplete or not meeting the conditions or only for part items, may liable for rejections.
- No queries regarding the status of the offer will be entertained at any time.
- The final supplier will be the combined decision of our technical team and management and no reason of final selection will be conveyed to any bidder.
- Payment terms with 30 days credit shall be preferred.
- The above inquiry is for one year contract with fixed price. No USD price fluctuation will be given for contract period.
- All the suppliers who get contract have to provide their fully automatic dosing system for PAA from dosing point (200 Kg PAA Drum) to PET Line as an attachment, also all the responsibility for the maintenance of the dosing system during the contract period is lies with supplier and separate price shall not be given for the system or maintenance of the same. Further, post completion of the contract, ownership of this dosing system shall be transferred to AFD from vendor as every time installation and removal of system upon completion of contract is not a viable solution. It shall be covered in the price of material itself and no separate payment to be given.
- All bidders have to provide EMD of Rs. 3 Lac (Refundable) along with the bid by way of RTGS/NEFT in following A/c. RTGS/NEFT receipt in purchase portal. The quotation received without EMD along with the RTGS/NEFT receipt shall not be considered. EMD will carry no interest.

- AFD will retain the same till successful award of contract to successful bidder. All unsuccessful bidder will get EMD back upon award of contract, where AFD will retain EMD amount of successful bidder till contract ends. In case of failure or non-agreement of providing services to the satisfaction level of AFD at the quoted or agreed rates whichever is latest, then this EMD will be forfeited and a contract will be terminated.
- In case bidder do not meet minimum legal/statutory requirement required by AFD, offer will be stands rejected.
