5. Your submitted offer must be valid for one year, as this is the yearly contract & no price hike will be given during rate contract period.
6. The price should be quoted on F O R destination basis. Offer to be submitted in given format only
7. Realistic and earliest response time should be indicated in offer.
8. It will not be binding on us to accept the lowest offer.

10. Offers which are incomplete or not meeting the conditions or only for part items are liable for rejection. 12. You have to submit security deposit of Rs 50,000 if contract will awarder to you. Security deposit will be returned after successful completion of the contract.

TERMS & CONDITION

1. Each unit will be provided 12 routine services (Preventive maintenance Visits) in a year. This will be done by monthly by your authorized & trained mechanics. It includes proper Camera body cleaning, adjustment and lenses cleaning with suitable cleaning agent and micro fiber clothing. All cleaning material in scope of vendor.
2. You have to provide unlimited nos. of breakdown calls during the contract period. You have to attend breakdown call within 24 hours after intimation from HR & ADMN department or concern user department.
3. Any type of problem must be short out maximum within 48 hours which includes any parts replacement either one camera or whole system. If you will fail to resolve the issue than penalty of Rs 1000 per day will be recover from your deposit. Or we will repair or replace the parts/system from another vendor & same amount will be recovered from you. Vendor shall be liable for repairing/replacement and will not escape from liability in the name of non-availability of spares/change of technology or absolute technology etc. reasons
4. You have to submit the bill every month & payment will be done within 30 days after receipt of invoice.
5. If we found any deficiencies in services than penalty will be imposed to you as decided by AmulFed Dairy, Gandhinagar Management
6. All tools & tackles are to be arranged by you at your cost during the service call.
7. You shall comply with rules and regulations in force within the premises of AFD/PFP & to ensure the precautions for safety of the plant & personals during working.
8. You have to submit visit report every time you attended the call & same is to be attached with the monthly invoice, without visit report attachment, payment will not be done.
9. You have to provide only trained & appropriately skilled persons and directly employed to carry out repairs & maintenance works.
10. Any damage to AFD & PFP property during the work will be borne by you.
11. The contract is comprehensive & you have to maintain the entire system on "As is & Where is installed basis", if required you have to replace parts or entire equipment free of cost. Shifting of any equipment should not be done without prior permission.

13. During preventive maintenance visit your engineer has to check operation of cameras & other parts of the system to have clear vision in LCDs located at our location. Cob ways from the cameras is to be removed by your person during the visit.
14. All data backup related problem is to be resolved by you at your cost & if required necessary training on how to take data backup is to be provided to our user department. Vendor to check and confirm of last 1 month back up on the day of visit
15. You have to provide I card of your workers who will attend service calls & will abide by safety & security rules.
16. Any dispute between the contractor and the AmulFed Dairy will be settled by mutual discussion only and the decision of the General Manger of AmulFed Dairy shall be final and binding on both the parties. In case a legal settlement is resorted to as a last refuge, the jurisdiction of such settlement will be Ahmedabad only.
